Contributions to Women on the Road California 2018 will be allocated as follows:

DSCC 50%, Feinstein for Senate 2018 8.33%, Friends of Mazie Hirono 8.33%, Friends of Maria 8.33%, Klobuchar for Minnesota 8.33%, Rosen for Nevada 8.33%, Tina Smith for Minnesota 8.33%.

Friends of Maria will not accept any contributions from a political committee under this Agreement. Any contributions from a political committee will be allocated 50% to the DSCC and 10% to each of the remaining candidate committees.

The first \$2,700 from a person and the first \$5,000 from a multicandidate committee to each candidate committee will be considered designated for the primary election and the second \$2,700/\$5,000 will be considered designated for the general election, unless the primary election has already occurred, in which case the contribution will be considered designated only to the general election.

Any contributor may designate his or her contribution for a particular participant. The allocation formula above may change if any contributor makes a contribution that, when allocated, would exceed the amount that the contributor may lawfully give to any participant.
